Meeting in Kyiv at Ukrainian Bar Association on 16th December 2019

The British Law Centre is delighted to be visiting Kyiv to start teaching the **2019-2020 Diploma in English Law & Legal Skills**. The Diploma is described in more detail below, but first we wish to say a few words about an event happening on **16/12/19**.

The first meeting of the Diploma course happens on **Monday 16**th **December (17.00-21.00)**. It takes place at the **UBA offices on 6 Khreshchatyk street**. We wish to invite UBA members who may be interested in joining the Diploma course to participate in the first meeting.

Upon enrolment, the Diploma's participants gain access to a <u>dedicated website</u> containing course materials, questions for discussion (during teaching visits) and practical skills exercises. If you have not yet enrolled, we would like to provide you with some materials in advance of the first meeting, to allow you to see what we will be discussing on 16/12. If you don't have time to prepare and simply wish to listen, no problem, but you may find the visit more understandable and more enjoyable if you are able to read something in advance.

We will begin the meeting by discussing the UK's (unwritten) constitution. We are enabling you to access some of the <u>reading materials</u> for this discussion and the <u>discussion questions</u> even without needing to be enrolled on the course/website. Simply click on the hyperlinks in this sentence.

We then start preparing a court case (R v Plumb). This will be the first of 3 (monthly) legal skills sessions which use this case as the backdrop to teach: case analysis; witness handling; oral advocacy and making speeches to judges and arbitrators. Even if you're not a trial lawyer, it will also help you to plan negotiations tactics and improve your public speaking in general. You will also learn a lot about English procedural rules, which are very different to those which apply in Ukraine. The materials for this are available here and a nice speech (by the author of the world-famous book on advocacy skills *The Devil's Advocate* is available by clicking here.

NB. If you aren't able to prepare, don't worry. You are perfectly welcome to come and watch/listen and to participate as much or as little as you feel comfortable doing.

I hope that this invitation suffices to whet your appetite for some more English law/skills training and that we will meet not only on 16th December but also regularly thereafter on the Diploma's monthly teaching visits.
